Program Description

The **Wyoming County Rural Arts Initiative (WCRAI)** seeks to enhance the vibrant arts community that already exists in Wyoming County, New York by creating an atmosphere in which creative art of all kinds can thrive. The WCRAI will support existing artists in the county while offering a place for artists currently living outside the area to gather and share their inspiration, creativity, and art. The WCRAI will offer studios, maker spaces, galleries, e-commerce, business support services, and related shops, all designed to enhance the creative arts community in Wyoming County and expand the existing tourist trade.

The initial component of the initiative is the **WCRAI Microenterprise Program** which offers grant funding uniquely tailored to assisting artists and artisans in establishing and enhancing businesses that are involved in the creative arts, which is broadly defined to include fine art (drawing, painting, sculpture, photography, film, writing, etc.), performance art (dance, music, theater, storytelling, etc.), and craft art (ceramics, jewelry, leather crafts, woodworking, furniture-making & restoration, metalworking, quilting, etc.).

Grant funding from the **WCRAI Microenterprise Program** will be available to subsidize the cost of studio or other maker space, rents for gallery space and other display venues, rental or purchase of artist's supplies and equipment, access to an on-line marketing and point-of-sale outlet, and other operating costs typically incurred in the creation of art for the commercial market. For those relocating to Wyoming County, affordable housing, support services, and part-time employment opportunities can be made available. Grant awards will range from \$5,000 to \$15,000 depending on the artist's needs.

About Wyoming County

Wyoming County offers the beauty, quiet, safety, and affordability of a small town lifestyle while being less than an hour's drive from the busy Buffalo and Rochester metropolitan areas. Wyoming County's geography is remarkable and highlighted by the stunning landscapes of Letchworth State Park and its three signature waterfalls that have been the inspiration for countless artworks. Arts and crafts in many forms have been celebrated throughout the county's history. The arts community is vibrant and well-supported by various organizations including the Arts Council for Wyoming County and the Wyoming County Chamber of Commerce and Tourism. Several art festivals and events are held in the county throughout the year that draw tens of thousands from the Western New York and Genesee-Finger Lakes regions.

The attractiveness of Wyoming County to the artist community stems from the inspiration offered by its setting, the friendliness and close-knit nature of its artists, and its affordability as a place to live and work. Overall, the county is an ideal place in which to create art and to establish a successful arts-based business.





The WCRAI Microenterprise Program is intended for:

- Artists who currently rely on, or intend to rely on their art as a primary source of income;
- Artists who will establish an arts-based business in Wyoming County or move an existing arts-based business to the county, as well as artists currently living and/or working at their art in Wyoming County;
- Artists who would like to work in a small town setting surrounded and inspired by other artists; and
- Artists who want to work in a community that values and supports art.

What does the program provide?

- Grant funding can be used to pay for rent and other occupancy costs associated with studio or workshop space, display space in private and cooperative galleries, and vendor space at art festivals and similar venues; purchase and rental costs for tools and supplies used in the creation or display of art; fees associated with website marketing, online sales transactions, and cooperative memberships; specialized entrepreneurship training for art-related businesses; marketing and marketing materials; and various other costs associated with the creation and display of art for commercial purposes.
- Support is available to address needs in such areas as housing, transportation, child care, part-time employment, and handicapped accessibility.
- All program clients will receive at no cost on-line entrepreneurship training specifically developed for arts and crafts businesses.
- Low-interest loans are available for additional business capital needs and one-on-one technical assistance is available to address business operational issues.
- Program clients will benefit from services, marketing, and events offered by the Arts Council for Wyoming County and the Wyoming County Chamber of Commerce and Tourism.

Who is eligible?

- Individuals who operate or who will operate a business in Wyoming County that relies on their artistic creations to produce income. The business may take any form (sole proprietorship, cooperative, corporation, LLC, etc.). Both new and existing businesses are eligible.
- For businesses that will not create new employment opportunities, the business owner/artist must meet certain income
 guidelines detailed in the application form.
- Grantees must provide a funding match equal to approximately 10% of the amount of the grant award.

Application Process & Grant Awards

Recommendations for grant awards under the *WCRAI Microenterprise Program* will be made by a committee based on the information provided by the applicant. Applicants are therefore encouraged to provide clear, concise, and thorough information in completing the application process. Applications will be rated by the committee using scoring criteria that will evaluate the applicant's overall resume, artistic proficiency, art portfolio including quality of design and execution, and ability and commitment to work in Wyoming County. Additional information may be requested and phone or in-person interviews may be conducted at the discretion of the committee. There is no "model" applicant. All applicants who meet the eligibility criteria will be considered.

Offers of grant awards will be made in writing and will include the amount of the award, the eligible use of the funding, and all terms and conditions associated with the award including the timing and nature of the art activity to be established in Wyoming County.

Timing and Other Post-approval Information

Grant recipients will be expected to begin working at their art in Wyoming County within 90 days of the award. All awards will be made consistent with the terms and conditions of a written grant agreement between the Wyoming County Business Assistance Corporation, a not-for-profit corporation that is implementing the WCRAI Microenterprise Program on behalf of Wyoming County, and the grantee. Immediately after awards are made and accepted, the committee will begin working with recipients who will be relocating to Wyoming County to coordinate the move and to offer assistance as requested.

For all grantees (current county residents and those relocating), assistance in the form of studio rents, fees and other costs for gallery space, website fees for marketing and sales of art, rental of furnishings, fixtures, tools, etc. will be paid as those costs are incurred (e.g., monthly for rents). Costs for purchases such as supplies can be paid at the time of purchase or reimbursed after purchase. Costs and fees associated with exhibitions, art and craft festivals, and similar functions can be paid as incurred.

For all grantees, assistance will terminate upon the expiration date of the grant agreement or at such time as the artist no longer gainfully works at their respective art in Wyoming County or otherwise fails to meet the terms and conditions of the grant agreement.

Box 249, Perry, NY 14530**. No original artwork should be submitted and no submissions will be returned to the applicant. Resume or Curriculum Vitae
